INTERVIEWER SHALL GIVE A VISUAL DEMONSTRATION OF OPENING THE CLOSURE USING A DEMO BAG. THE CLOSURE SHALL BE RESECURED. AFTER DEMONSTRATION PUT BAG OUT OF SIGHT.

NO VERBAL INSTRUCTIONS ARE TO BE GIVEN!!!

(HAND CHILD BAG--START STOP WATCH!)

SECOND FIVE MINUTES

A. Container did not fail

- Child did not damage bag, or pull, twist off or remove closure.
- Child did not attempt to open closure on the bag.

B. Container failed to meet CR standards

- Child pulled the closure apart, releasing the lock.
- Child was able to pull or twist off the closure in a way which released or exposed the bag contents.
- Child was able to damage the bag or zipper by penetrating, cracking or pulling it in a way which released some of the contents of the bag.
- Child used teeth.

RECORD TIME BAG OPENED OR DAMAGED, EXPOSING CONTENTS _____min/sec

COMMENTS/OBSERVATIONS (BE VERY SPECIFIC ABOUT CHILD'S ACTIONS)

MARK TESTED BAG WITH CHILD'S AGE IN MONTH / SEX . RECORD THE MINUTES AND SECONDS IT TOOK TO OPEN.

REMIND CHILD NEVER TO ATTEMPT TO OPEN CONTAINERS WITHOUT AN ADULT PRESENT!!!!!!!!!!!!
